Natural persons holding securities, personally or through a legal or conventional representative, will submit the IBAN code collection form to Depozitarul Central, specifying the bank and the account (IBAN code) opened in the name of the Holder of financial instruments, accompanied by:

- > copy of a valid ID showing the personal identification number certified as "according to the original"
- account statement od a bank document (signed and stamped) confirming the existence of the account in the name of securities Holder, specifying the IBAN code, in original;
- copy of the documents certifying the quality of the applicant as legal or conventional representative, as the case may be – certified by the Holder as "according to the original"
- Copy of proof of payment of IBAN code collection fee (in case the documents are sent to Depozitarul Central);

Legal persons holding securities, through legal or conventional representative, will send to Depozitarul Central the IBAN code collection form, specifying the bank and the account (IBAN code) opened in the name of the Holder of financial instruments, accompanied by:

- > copy of the certificate of registration certified by the Holder as "according to the original";
- copy of the document certifying the quality of company's legal (certificate issued by the Trade Register / equivalent entity for foreign entities) certified by the Holder as "according to the original";
- copy of the documents certifyng the quality of legal or conventional reresentative of the application signatory's, as the case may be - certified by the Holder as "according to the original";
- account statement od a bank document (signed and stamped) confirming the existence of the account in the name of securities Holder legal person, specifying the IBAN code, in original;
- copy of proof of payment of IBAN code collection fee (in case the documents are sent to Depozitarul Central);

The documents presented in a foreign language will be accompanied by the legalized translation in Romanian and if they are issued by a foreign authority, they must be apostilled or superlegalized, as the case may be.
